Docks

- New docks New ramps were ordered and are here, need to install. Originally wanted to add 20' to each one this year. Ramps \$900 40' of dock \$2600. Looking at options for utilizing one side of the new docks as reserved.
- Beach Dock is being resurfaced this year.
- Slip Dock Boards are being replaced by surplus from old floaters and beach dock. Working on budgeting to resurface next year completely.

Supplies are in plastic box mounted on the outside of the Gathering Room on the SW corner.
